Universiteit Antwerpen

The <u>University of Antwerp</u> is proud to host the **2025 Annual Conference of the European Policy for Intellectual Property Association**.



The University of Antwerp is a young, dynamic, publicly funded and fully accredited Belgian university. It was founded in 2003 after the merger of three universities: UFSIA (*Universitaire Faculteiten Sint-Ignatius Antwerpen*), RUCA (*Rijksuniversitair*

Centrum Antwerpen) and UIA (*Universitaire Instelling Antwerpen*). It integrates the assets of its historic roots with its ambition to contribute positively to society, carries out its tasks in a spirit of academic freedom and responsibility, and espouses active pluralism.

The University of Antwerp is characterised by its high standards in **pioneering**, **creative and innovative scientific research** which strives for international excellence. It stimulates both basic and applied research and their valorisation. It has 15 Centres of Excellence (CoE) across all scientific disciplines, each of which is an international flagship, bringing together researchers of proven scientific quality and impact. The GOVTRUST Centre of Excellence, which is co-organising the EPIP2025 conference, is an example of such a research excellence consortium, bringing together interdisciplinary expertise on trust and multilevel (regulatory) governance.

The University of Antwerp also offers **excellent internationally accredited academic education** – closely connected to its scientific research – to students from all social groups and of all generations. Students acquire knowledge about research results during lectures, through their course materials and digital media. The EPIP 2025 conference takes place at <u>University of Antwerp's 'Stadscampus'</u> (city campus). The Stadscampus is a 15-minute walk or 5-minute bike ride from Antwerp Central Station. The panel sessions are spread across the Meerminne, Brantijser and Kattenstraat buildings, all within a few minutes walking distance from each other. 


WiFi Access

She served as Head of the Department of Commercial Law from 2014 - 2016 and as Deputy Dean, Postgraduate Studies in 2017 and Jan - June 2019 and in 2022. She is a member of the African Policy, Research & Advisory Group on STI, a member of the Advisory Board of the African Network of International Economic Law (AfIELN), and of the Academy of Science of South Africa (ASSAf). She also serves on the the AU Scientific Technical Research Commission ASRIC Taskforce on IP Protection in Joint

Research and Collaboration During Outbreaks and a member of the African Continental Free Trade Area (AfCFTA) trade and industrial development advisory council.

Caroline has served as an expert for various institutions including the African Union, World Intellectual Property Organisation (WIPO), Economic Commission for Africa (ECA), the AfCFTA Secretariat, and the Southern African Development Community (SADC). In August 2024, she was awarded the South African Women in Science Awards (SAWISA) Distinguished Women Researchers' Award (Humanities and Social Sciences) by the Department of Science and Innovation.

She is a member of various academic associations such as the International Association for the Advancement of Teaching and Research in Intellectual Property (ATRIP), the South African Association of Intellectual Property Law and Information Technology Law Teachers and Researchers (AIPLITL), and the Society of Law Teachers of Southern Africa (SLTSA). Bhaven N. Sampat has recently joined Johns Hopkins University, with appointments at the new School of Government and Policy and the Carey Business School and a Research Associate in the Productivity, Innovation, and Entrepreneurship Program at National Bureau of Economic Research (NBER).

An economist by training, his research focuses on the economics and political economy of innovation and innovation policy. Among other topics, he has studied US and global life science patent policy, the politics and economics of publicly funded science, the roles of the government in pharmaceutical innovation, and the economic history of

the US biomedical research enterprise. An overarching theme in his research is how science and technology policies can best be designed to contribute improvements in health and other socio-economic outcomes.

Before joining ASU in 2023, he was Assistant, Associate, and Full Professor at the Department of Health Policy and Management at Columbia University's Mailman School of Public Health. He has held visiting positions at NYU Law School and NYU's Wagner School of Public Service, among other institutions.

He is a founding member of the National Bureau of Economic Research's (NBER) Innovation Information Initiative (I3), a data collaborative for open innovation data and related analytics, tools, and metrics, a member of the editorial advisory board of the Milbank Quarterly, a leading health policy journal, and an affiliated professor in the Abdul Latif Jameel Poverty Action Lab (J-PAL) Science for Progress Initiative.

Sampat's current research is focused on three main projects: (1) An NSF-funded project assessing the long-run effects of the World War II research effort on U.S. science, innovation, and science and technology policy; (2) Research on pharmaceutical patent policy, innovation, competition, and access to medicines in the U.S. and globally; (3) Historical and quantitative research on the economics and political economy of the U.S. National Institutes of Health (NIH), the largest single funder of biomedical research in the world. He also works on creating and validating new measures linking publicly-funded research investments to private sector patents, drugs, and other socio-economic outcomes, a topic of long-running interest throughout his career.

About Coop Centraal



Coop Centraal is a supermarket run by its own shoppers. As a cooperative, all decisions are made democratically by its members. They take this model a step further by asking each member to contribute three hours of work to the store each month.

As a grassroots initiative, Coop Centraal explores how a food co-op can respond to major societal challenges. Whereas access to quality food remains unequal, food also has the power to connect people across cultural divides.

Coop Centraal was founded by former climate strikers who wanted to build a practical alternative to traditional business models and many of them were and/or are linked to the University of Antwerp. It quickly became a laboratory for testing ideas from philosophy, biology, sociology, history, and economics. Three years in, Coop Centraal has grown from a dream shared by a few into a store with nearly 300 members from all walks of life.

Cabardouche

Cabardouche is a small cooperative brewery in Antwerp's neighbourhood Borgerhout. In the past, each Antwerp district had its own brewery — but over time, large beer companies bought out and shut down the smaller ones. Cabardouche aims to bring back the spirit of local brewing. Their brewery is located in a former brothel tucked under the train tracks; these spaces were known as "cabardouches" during the Napoleonic era. They brew a wide range of beers, each named after a fictional character who could have once lived there. If you're in the area, their taproom on the *Engelselei* is well worth a visit.



(On)kruid



(On)kruid makes tea from weeds. Often seen as pests, weeds are actually vital for biodiversity, offering shelter and food to insects and birds. On most farms, these plants are removed using chemicals because they are seen as economically worthless. By turning weeds into tea, (On)kruid gives them new value. The company pays farmers to create "weed corridors" across their fields, providing safe habitats for wildlife. In return, (On)kruid harvests these plants to produce unique herbal teas.

I Just Love Breakfast

Natalie, the founder of *I Just Love Breakfast*, spent years working as an architect around the globe. During her travels, she fell in love with the diverse world of granola. When she returned to Belgium, she could not find anything that matched what she had had abroad, so she started making her own. What began as a passion project quickly turned into a thriving business. Today, her handmade granola is produced just 20 kilometres from Antwerp in Puurs.



Coup de Chocolat



Coup de Chocolat takes sustainable chocolate to the next level. The cocoa industry is notorious for unfair labour practices and ecological damage. Today, 90% of cocoa is traded by just three companies, turning chocolate into a cheap commodity.


Coup de Chocolat is working to reverse that. They buy directly from small-scale producers, import their beans emission-free via cargo sailing ships,

and have won multiple awards for their exceptional flavours. Much like wine, their chocolate lets you taste the terroir of the beans: rich, complex, and deeply satisfying.

Cordon Coffee

Koen, founder of *Cordon Coffee*, is an uncompromising entrepreneur who always chooses ethics first. He started Cordon in 2012 as one of Antwerp's first independent roasters, using green energy and delivering coffee by bike.

After learning that farmers typically earn just 1% of the final price of a cup of coffee, Koen tried to explore fairer alternatives. That search led him to partner with *This Side Up*, a transparent distributor that breaks down exactly who earns what along the value chain.





Nona's Artisan Bakery



Nona is a baker who takes vegan pastries to the next level. Working with whole grains and locally sourced ingredients, she is dedicated to crafting plant-based alternatives to traditional *koffiekoeken*: the classic Sunday morning pastries beloved in Belgian households.

For this occasion, we asked Nona to create special cookies inspired by Het Steen, Antwerp's iconic riverside castle and one of the city's most recognisable landmarks.

If you arrived in Antwerp by train, you may have passed by the Antwerp Zoo without even knowing it. Next to the Antwerp Central Station, which is an architectural masterpiece in its own right, lies the Antwerp Zoo. It is one of the oldest and most famous zoos in Europe and offers an oasis of calm in the heart of the city. The beautiful gardens, the characterful listed buildings and, of course, the animals: it is the perfect setting for a fun outing with your partner, family or colleagues.

As the home of Pieter Paul Rubens, Antwerp has its fair share of cultural destinations and museums worth visiting. Although the Rubens House is currently closed for a thorough renovation, you can encounter the work of Rubens in several other places in Antwerp, such as the Plantin-Moretus Museum (UNESCO World Heritage site), the Royal Museum of Fine Arts Antwerp, and the Cathedral of Our Lady. Especially the Royal Museum of Fine Arts Antwerp (KMSKA) is an absolute must-visit, where you can admire a beautifully renovated building and discover seven centuries of the finest art in the backdrop of a completely new setting. This palace of the arts is home to a staggering collection of over 13,000 pieces. Among them are works by many great historic European painters, including Rubens, James Ensor, Jan van Eyck, Pierre Alechinsky and many, oh so many more. The KMSKA is located in the Zuid neighbourhood, one of Antwerp's vibrant and trendy neighbourhoods, with wide avenues, stately townhouses, lovely squares, interesting shops and a number of world-class museums. Thanks to the many cafés and restaurants, there are also plenty of places where you can have a drink or something to eat.

In the old city centre stands the <u>Cathedral of Our Lady</u>, a monumental building that has graced the Antwerp skyline since the beginning of the 14th century. The cathedral's architecture is gothic, while its interior is baroque. And that is definitely due to Rubens and four of his masterpieces that may be found here. Another church worth visiting is the <u>St. Charles Borromeo Church</u>, which is sometimes considered the essential Rubens church with both paintings and sculptural works from his hand. Located on the picturesque Hendrik Conscienceplein, this triumphant baroque church is certainly an eye-catcher.

Another place worth visiting is Antwerp's iconic Grote Markt. You can admire the beautiful renaissance Town Hall (UNESCO World Heritage) and the countless 16th-century guild houses, and enjoy a drink on one of the many terraces. Another must-see in the square is the impressive Brabo Fountain, depicting the legend from which Antwerp is said to have derived its name. Near the Grote Markt, look for the hidden, picturesque Vlaeykensgang, a medieval alley that transports you into another era. If you head towards the river, you will encounter the medieval castle Het Steen, currently a tourist information centre.

Local De Koninck beer ('bolleke')

Het Eilandje (Little Island), so-called because it is surrounded by water, has long had a reputation as one of Antwerp's coolest neighbourhoods. It breathes water and exudes charm with its monumental warehouses, lanterns, and cobblestones. A focal point of the neighbourhood is the stately Museum aan de Stroom, or MAS. This city museum is well worth a visit in itself, and its breathtaking rooftop panorama doubly so. Visit the rooftop (free access!) at sunset for an ultimate other-worldly view of the city, the river and the port. You can also explore the area's many culinary hotspots. In addition, the many pubs and cafés in this area are perfect places to familiarise yourself with that other great Belgian heritage item: beer. You may want to order a glass of De Koninck, the local brew. One (or several) of these 'bollekes' will assure you of a good night's sleep.

Finally, venture a little more to the north to encounter another highlight: the <u>Port House</u>. The structure houses the headquarters of Antwerp's Port Authority, which manages one of the largest ports in Europe. This modern icon, where a sparkling diamond is perched on top of an old fire station, was created by architect Zaha Hadid. The stunning structure soon became a city landmark, an instantly recognisable part of the skyline.



Trams and Buses



Antwerp has a dense public transportation network. Buses and trams are available to take you to different parts of the city. A single ticket within the city is €3 and allows you to use public transportation (buses and trams) for one hour. You can consider buying a *De Lijn* card (10 rides for €21), or a day of unlimited travel (€9). Tickets can be purchased in advance via the sales points in the city. On all buses and trams of De Lijn you can also pay for

de app, the <u>website</u> or at the <u>sales points in the city</u>. On all buses and trams of De Lijn you can also pay for your ticket 'contactless' via the white terminal, by using your contactless bank card (Maestro, Mastercard, VPAY and Visa), payment apps (Apple Pay, Google Pay), or wearables (Fitbit Pay, Garmin Pay).

Cycling and Scooting

Antwerp is a bike-friendly city. The distances are not too large, the bike lanes are flat and with the right gear, you can cycle all year round.



Velo is Antwerp's metropolitan bike scheme. There are check-in and drop-off zones of the city bikes throughout the entire city. To ride Velo you have to register beforehand. You can buy a day pass for €5 or a week pass for €12. After purchasing a day or week pass, you can use the bikes for a maximum of 30 minutes per session. Donkey Republic is a bike rental service. It offers normal and electric bikes; short or long bike rentals and you pay as you go via the app. Find more information on www.donkey.bike/cities/bike-rental-antwerp/.

In Antwerp we have **shared electric scooters** from <u>Voi</u>, <u>Lime</u> and <u>Poppy</u>. They all work with a free-floating system, meaning that they do not have a fixed parking spot, but can be found scattered throughout the city. To use a scooter, you must first download the Voi, Lime or Poppy app. Use the app to find the closest scooter and scan the QR code. After your journey, leave the scooter in a place where it cannot obstruct traffic and end your journey in the app.


